- 1- NO RESIDENCE SHALL BE ERRECTED COSTING LESS THAN \$2000.00
 - 2- NO LOTS IN THIS SUBDIVISION TO BE SOLD, CONVEYED, LEASED OR OCCUPIED BY ANY OTHER THAN OF THE CAUCASIAN RACE, OTHER THAN MAIDS, COOKS, CHAUFFEURS, ETC. DOMICILED WITH THE FAMILIES RESIDING THEREON.
 - 3- LOTS 3 TO 7 INC. AND 10 TO 14 INC. TO BE USED FOR RESIDENTIAL PURPOSES
 - 4- LOTS 1-2-8 AND 9- MAY BE USED EITHER FOR RESIDENTIAL OR BUSINESS PURPOSES.
 - 5- THE MAIN BODY OF ANY RESIDENCE CONSTRUCTED ON LOTS 3 TO 7, AND LOTS 10 TO 14, INCLUSIVE, SHALL NOT BE NEARER THAN 30 FT. FROM ST. LINE.
